Minutes of the Bubbenhall Parish Council Meeting, Tuesday 20th January 2015 in the Village Hall

1. Apologies for absence Apologies were received from Cllrs Redford, Hammond and Nwachukwu.

- **2. Declarations of interest and dispensations** There were no declarations of interest.
- 3. Minutes of previous meeting on 9th December 2014 were agreed and signed by the Chair
- 4. Matters arising:
 - a. Problem with Stoneleigh Road. Where it had been repaired a trench was appearing on the side of the road. This was confirmed to be by Quarryfield House. Clerk to contact Cllr Redford
 - b. A hole was appearing on a road running through the village. This was confirmed to be on Lower End approaching the Village Hall. Clerk to contact Cllr Redford
- 5. Vacancy on Parish Council

Jan Lucas was formally co-opted on to the Council; he received the declaration of acceptance and interests forms and took a seat with the Council for the rest of the meeting.

6. Highways:

Cllr Powell reported that he is continuing to contact various individuals regarding road safety in and around Bubbenhall. The "Unsuitable for HGV Vehicles" signs have been quoted as £3,000 per sign. The question was raised whether or not this price applied if the sign was being replaced rather than replacing and concreting in new posts. Cllr Powell to clarify the issue of the costs. It was pointed out that some of the signs were in the wrong place. Cllr Powell will send a note to Cllr Redford highlighting all the issues. Cllr Lucas is continuing to collate the information regarding HGV movement though and in the vicinity of Bubbenhall. Cllr Powell will also forward this information to Cllr Redford.

The problem of the large amount of litter which appeared on the A445 was raised. Initially it was thought to be Local Authority recycling. However, it now appears that it may be landfill. Without concrete evidence it was agreed that it is difficult to prove where the problem lies. Further monitoring will be required.

7. Local Plan:

Local Plan – Acknowledgement of representation received. The Local Plan will go to Council next Wednesday 28th January 2015. The decision regarding Gateway is still expected to be Tuesday 3rd February 2015.

Neighbourhood Plan update. Appointment of consultants. It was confirmed that all parishes have now agreed that Kirkwells should be appointed as the consultant. It was confirmed that the council would try to obtain a grant to support the costs. The Bubbenhall Parish Council representatives are Cllrs Shattock, Haynes and Harrison.

8. Local Elections.

Timetable – The timetable was circulated to the councillors prior to the meeting. It was confirmed that the Annual General meeting of the Parish Council would take place on Tuesday 12th May. The period between the meeting on 3rd March and 14th April 2015 would

be used to publicise the election and commence the nomination period. Each nomination must be separate and hand delivered. It is important that all councillors standing for reelection are available to receive and submit their nominations. The last date for Receipt of Nominations by elections authority is **9**th **April 2015 4:00pm.**

9. Business from members of the public

Dog Fouling alongside Public Right of Way - There is currently a sign which was put up by the dog warden. However, a more permanent solution needs to be found.

Enquiry from Bubbenhall Village - puddle outside house junction of Watery Lane and Stoneleigh Road. A comment was made that this was a very large puddle which had appeared after the road had been resurfaced. Clerk to contact Cllr Redford

10. Finance

Financial report - payments and summary schedule. The Clerk presented the financial report (payments and summary schedule attached). Cllrs Baker and Haynes signed the cheques. Precept/budget – The spread sheet with the proposed budget was circulated to cllrs prior to the meeting. It was agreed that an additional £1,000 would be made available for possible "unsuitable for HGV vehicles" road signs (See item 6) and £3,000 for Safety grass, slide, swing and cable way in the playing fields. (See item 13)This decision was made following the Health & Safety recommendations. Additionally it was decided to include a new Parish Council notice board to be positioned outside the village hall. The current board is in a very poor state and has no cover to prevent the effects of adverse weather conditions. Cost for this is budgeted at £865.

Cllrs were informed that the 2014-2016 National Salary Award pay scales have now been agreed. Clerk to receive pay award according to new pay scales.

Bank account. Clerk to investigate the possibility of a higher interest bank account. It was noted that any new account could **not** be on-line.

She has suggested that a meeting could be arranged for the councillors to discuss the issues with the contractor. Cllrs Haynes and Harrison agreed to attend. Clerk to sort possible dates

The pommel seat needs to be replaced in the play area. Also Safety grass, slide, swing and cable way need replacing following recommendations from Health & Safety. Youth Space has no issues to report.
