- 1. Apologies for absence: Apologies were received from Cllr P Redford(WDC), Cllr N Harrington(WDC) and Cllr C Pilgrim
- 2. Declarations of interest and dispensations: No declarations were received
- 3. Minutes of previous meetings on 21st February 2017: These were agreed and signed by the chair.
- 4. Matters arising:
  - i. Invitation to the Neighbourhood Police to Parish Council Meeting.
    - This item will be carried forward to the next meeting
  - ii. Cllr Lucas would ask Ian Henderson to provide the path numbers.
    - Resident has offered to cross check footpaths.

    - The response asked for number plates as evidence. If this continues an attempt will be made to obtain number plates.

- 5. Neighbourhood Plan:
  - i. Update: Cllr Haynes & Consultant Louise Kirkup to attend meeting with WDC to discuss the current situation and what needs to be addressed.
- 6. Local Plan:

i. Warwick District Local Plan Main Modifications consultation Friday 17th March – Friday 5 May 2017 Cllr Shattock & Cllr Lucas attended Stoneleigh & Ashow Parish Council meeting at on 9th March 2017 at Ashow Village Hall where Dave Barber, Policy and Projects Manager, Warwick District Council, gave a report on the Local Plan. The Planning Inspector has made modifications to the plan (89 pages), and a consultation on the inspectors' modifications is about to begin. Mr Barber confirmed that at the end of next week, Warwick District Council will be informed of a start date for the six weeks' period of consultation regarding the modifications. The Planning Inspector has consulted with WDC but has asked that the modifications are kept confidential until the consultation starts. It was agreed that Bubbenhall Parish Council would send a letter to the Planning Inspectorate.

i. Mowing contract for 2017/18

It was agreed to review the contracting bids in about 2 weeks' time. In the mean-time Clerk will contact Heritage and ask that they mow playing fields. This will be discussed at the next meeting.
